Blairsville City Council talks signs in regular meeting

meeting on Tuesday, Oct. 3, the Blairsville City Council approved an amendment to the current alcohol ordinance and heard from concerned downtown business owners regarding signage around the square. For several months,

During the regular

the City has been diligently working on ordinances with the intent of mirroring Union County ordinances as much as possible, to lessen confusion for county and City residents.

Recently, the Council reviewed the City's current alcohol ordinance and upon doing so decided to move forward with an amendment to regulate signage advertising or promoting alcohol sales within the City Limits.

After hosting a public hearing for any concerns or questions regarding the amendment, the Council unanimously approved the new amendment. The amendment includes three sections regulating signage advertising or promoting alcohol sales.

This amendment can be found in Sections 10-76(a), 10-76(b) and 10-79(n) of the Alcohol Ordinance 2017-03. This amendment does not currently mirror that of the county but the Council may return to the ordinance in the future for further amendments.

Signage in the downtown area made its way into conversation for a second time during the meeting when Dick Mills of 7M Family Farms and Nate's Restaurant addressed the Council concerning a recent event regarding one of the restaurant's outdoor signs.

According to Mills, he was asked by Blairsville City Police to remove a sign promoting the business from the City sidewalk. Nate's is located in the Seasons Inn Plaza, rather than directly on the square, and since the restaurant's location is somewhat hidden, Mills thought the small sign on the sidewalk would be acceptable.

Mills went on to state that he felt the request was unfair due to other businesses in the downtown area placing not only signs, but chairs and tables as well, on City sidewalk with no repercussions.

"We had put an extra sign out there on the corner,' said Mills. "All it was saying was our daily special. This is where I have an issue. I'm not allowed to put a sign out on City property but it's no different than every other restaurant on the square that has tables and chairs and signs on City property.

I'm all for every business in here to do as much as they can, because we all have to survive, but it's all City property. How is that fair to anyone else in here, as a business.

"That's the only complaint that I have. If we're going to push that on one business, then lets make it for everybody.

"I just want to bring business in. I pay taxes just like everybody else, I just want to be judged fairly.

marijuana coming from the vehicle," said Union County Sheriff's Office Detective Lt. Daren Osborn. "Deputy Patton told Mr. Wrenn, 'I smell marijuana, where is it at?' Mr. Wrenn told him that he had some in the console of his vehicle. And he did, it was a Mason jar filled with some impressive marijuana buds

inside. "If you find a controlled substance, you can search the vehicle," Detective Lt. Osborn said. "Deputy Patton searched the vehicle and found a 13gallon white garbage bag with lots more marijuana buds. It was about three-quarters full."

Wrenn was arrested and charged with failure to maintain lane and distribution of marijuana, Detective Lt. Osborn said.

In a separate incident, Union County Sheriff's Deputy Drew Stewart arrested two North Carolina women following a routine traffic stop on Georgia 515.

Lorri Walker Kilby, 46, of Franklin, North Carolina, and Jennifer Ann Bryant, 47, of Murphy, North Carolina, remain in custody after a search of their blue, Volkswagen Beetle uncovered six grams of methamphetamine, Deputy Stewart said.

"The driver of the vehicle, Jennifer Ann Bryant, made an improper turn into Walmart," Deputy Stewart said. "I initiated a traffic stop. Once I got them stopped, I talked with them and there were indicators that there was some criminal activity involved.

"They gave me consent to search the vehicle, and I discovered several Baggies of methamphetamine," Deputy Stewart said. "There were six grams of meth, and the way it was bagged, it was destined for and charged with possession of a controlled substance with intent to distribute, possession of drug-related objects. improper right-hand turn, and turn signal violation, Deputy

Stewart said. 'The vehicle they were using was impounded and is here at the Sheriff's Office," Deputy Stewart said Sunday night. "They're still being held in the Union County Detention Center.'
