Log Creek Bridge is exciting news for Union County residents.

"This is great news for our community and construction has not impacted traffic," Dunn said.

The new bridge is being built parallel to the existing bridge to the west.

Traffic continues to use

the existing bridge until the new bridge is finished.

Traffic will be shifted over to use the new bridge when completed, and the original bridge will be demolished.

Commissioner Paris said construction workers may have to wait until lake waters recede before the exist-

ing bridge can be completely demolished.

The existing bridge was built in 1940. The new structure, when completed, will include shoulders on both sides of the bridge and be built to current engineering standards improving safety for motorists, Paris said.

that convenience. The client agrees to pay that fee. We get our money in full.

"We have people calling us and asking if they can pay with a credit card," she said. "Our answer has been no. Not being able to accept these payments, five out of 10 persons end up on probation.

"There's people out there willing to pay with a debit or credit card and we get \$333 and we don't have to wait a year's time to get those funds," Neely said.

Mayor Pro Tem Bud-

dy Moore asked if someone wanted to pay cash, what would be their options.

"You don't have to pay by debit or credit," she said. "If you want to pay cash, we accept cash. The only reason we're doing this is for those who wish to pay by debit or credit cards."

"There is no fee to set up this service," Neely said. "The City of Hiawassee uses this same system and they're in the process of getting set up."

Neely said the system

would save folks from having to drive back to Blairsville if they're from out of town to pay their traffic fines.

"Folks who have to drive 75 miles to come pay a fine will pay a fee to be able to handle it over the phone with a debit or credit card," she said. "We have a lot of folks who ask to pay with a debit or credit card."

The Council voted unanimously to approve the agreement with Courtware Solutions.

A vital part of the application process is securing the interest of parents/guardians willing to send their child to the Union County Primary School to attend a newly formed Pre-K program.



# Fraud alert in Union County

A letter from the "Records Transfer Services" isn't what it seems, Union County Sole Commissioner Lamar Paris said.

These letters which have an address of 2522 W 41st Street #400, Sioux Falls, SD 57105, are arriving at Union County homes and offer the service of providing a copy of the recipient's property deed for a cost of just \$63.

The problem is, Paris said, property owners can make copies of their land documents at the Union County Courthouse for just 50 cents.

A similar scam was ongoing in Towns County last year, with letters addressed from 925B Peachtree St., NE,

#745, Atlanta, GA 30309. That group offered the same service for just \$89.

"They target the elderly," Paris said.

If you read the paperwork sent by "Records Transfer Services," it's pretty easy to decipher that something smells fishy.

On the letters, there is one disclaimer after another telling the recipient that this service is not associated with any government agency.

It also discloses that the recipient can obtain a copy of their deed or other records from the county recorder in the county where their land is.

The county recorder is Judy Odom, and the folks that

work for her office.

It's best to watch for these letters in the mail.

The letter includes Union County public information of the property owned by the letter recipient.

It breaks down and provides a detailed description of the recipient's property.

The records are obtained through public information, and "Records Transfer Services" offers to provide a property profile to the recipient that includes detailed information all for the low price of \$63.

"If you need a copy of anything on file, Judy Odom will get you one for 50 cents or thereabouts," Paris said.
